Reasonable direct Charter flights and regular flights fly out of Canada, the US & Europe.










One of the Safest Countries in the World




Panama is rated one of the safest countries in the world, with the same **tourism safety rating as the United States.**

Political Stability





The days of Noriega are long gone. Panama enjoys a **stable**, **constitutional democracy** and Latin America's most stable economy.

As of May 2009, The president of Panama is Ricardo Martinelli, a wealthy businessman and owner of "Super 99", a major Grocery Store Chain in Panama. The Jury is still out on Martinelli. He seems to be tackling corruption in his country and promoting Foreign Investment and New Business development, but his Pro-Big Business policies seem to be tough on labour unions and environmental laws, in his quest to grow Panama's economy.

Panama faces no threats of hostility either domestically or internationally.

The world community, led by the US, would never let Panama deteriorate into instability, due to the international importance of the Panama Canal

Prior to the Americans giving up their military bases in 1989, Panama made a pact to be protected by the Americans and the **treaty gives the United States the right to intervene militarily** to protect access to the canal.



The Panamanian Government no longer has an Army of it's own. They do have a National Police Force, which patrols the boarders and is involved in all regions of the country.

The Canal generates billions of dollars in revenue for the country and gives Panama the **most** stable government in Latin America.

Modern Infrastructure





Panama has a First World infrastructure.

Panama City is truly a cosmopolitan Metropolis with modern amenities and facilities. Spectacular, state-of-the-art Skyscrapers are shooting up across the city.


In Panama, you have the ability to travel from the more tropical climate to the cooler mountain air in less than an hour.



All 3 major Bond Rating Agencies, Standard & Poor and Fitch included, have given Panama the coveted 'Investment Grade' Rating."**The World Bank** says, "Today, the Panamanian economy is among the fastest growing and best managed in Latin America" and the **World Tourism Organization** calls it the "fastest growing tourism market in Latin America".

It is not uncommon for shrewd investors coming to Panama today, to **buy a condo in Panama City, a beach house and a mountain home, all for less than the price of the one property they just sold back home.** Many are buying now even though their retirement may be still several years away, seeing investing in Panama as part of their retirement plan and a viable alternative to RRSP's, especially given the volatile performance of mutual funds and stock markets.

Foreigners can buy and own their own clear titled land in Panama, without a local intermediary. With a few exceptions, foreigners can also start and own any type of business in Panama.

Panama's currency is the US dollar. Your bank accounts and investments are also in US dollars. As a result, **your investment does not run the risk of currency devaluation**; as we all know, in times of economic instability or recession, the investment community invariably runs to the 'Green Back' for security, so your investment is safe, and will most likely benefit from the exchange rate over time.

Panama is one of the world's freest economies and a member of the World Trade Organization. There are also no currency exchange controls, so your cash is allowed to flow freely and anonymously in and out of Panama. Panama's open economy offers the lowest tariffs in the region, which has helped increase foreign investment in both the public and private sectors.

After Switzerland, Panama is the second largest banking centre in the world, currently hosting over 150 international banks from 35 different countries, including giants such as HSBC, Lloyds, Bank of Tokyo, Bank of Boston, Banco National de Paris, Scotia bank and Citibank which all provide complete financial services to foreign investors in Panama.

Panama is the most modern banking center in Latin America.

According to Sr. Barrelier, Panama's Superintendent of Banking, "Panamanian Banks have maintained double the liquidity required by law and as such, have minimal exposure to International market fluctuations".

Monetary discipline has kept inflation very low; under two percent for the last 40 years.

As a result, Panama City bustles with international business and many multinational corporations, such as Caterpillar and Samsung, have moved their Latin American headquarters there.


Best Bank Secrecy Laws in the World

50% off recreation & entertainment across the country, including sports events, ballet, parks, movies, concerts, theater, etc.

50% off hotel accommodations Monday-Thursday, 30% off Friday-Sunday

30% off Public Transportation (Bus, Boat and Train Fares)

25% off international and domestic airline tickets

10% off already low-priced prescription medicines

15% off eye exams and hospital bills (if no insurance applies)

Minimum wage is \$250 a month or \$1.56/hr. based on a 40 hour, 5-day workweek

A full-time maid can be hired for approx. \$200 a month

A full-time driver \$250 a month

A gardener costs \$10-15 dollars a day.

Food is very cheap. 8 people can dine at an "expensive" restaurant, enjoying a multi-course meal with great quality wine for roughly \$200!

Beer is .50 cents.

Taxis are \$1.50 to \$3.50 on average for a ride within Panama City.

Telephone and cell phone service and cable is roughly \$30 a month

Internet access is \$14 a month, wireless a bit more.

For \$12 you can travel across the country on a luxury bus from Panama City to Chiriqui Province in West Panama.

For around \$50 you can take the same trip by flight!

Panama has a rich and thriving Indigenous Indian culture with 6 different tribes and unique native arts and crafts.








Feels Like Home (without the snow)
